**BOARD OF DIRECTORS MEETING  
MAY 27, 2009**

The Board of Directors of West Valley Sanitation District of Santa Clara County, California, convenes this day in regular session at 6:00 p.m. at the District office, 100 East Sunnyoaks Avenue, Campbell, California, with the following members present: Dan Furtado, Diane McNutt, Curtis Wright, and Chuck Page, Chairperson. Director Ken Yeager is absent. Staff present are Robert R. Reid, District Manager and Engineer; Charles T. Kilian, District Counsel; Edward H. Oyama, Director of Engineering and Operations; and Joanna Fuller, Secretary.

The minutes of the previous meeting are approved as presented.

Oral communications: This portion of the meeting is set aside for persons wishing to address the board on any matter not on the agenda. There is no public comment.

Written communications: No written communications have been received.

Reports: The following reports are submitted for action in one motion:

Investment of District Funds: Report on commingled funds invested by the County of Santa Clara for West Valley Sanitation District, as of April 30, 2009; and the Quarterly Report from County Controller for the period ended March 31, 2009.

Consolidated Income and Expense Statement of West Valley Sanitation District for the period ended April 30, 2009.

Evaluation of Business Risk Exposure: The manager reports that two workshops were held with District staff, facilitated by a consultant, to identify potential risks faced by the District, areas of responsibility, and suggested mitigation measures. A business risk register was subsequently developed and submitted for the board's review. The board comments that they are pleased with the report, and the board directs staff to provide periodic updates.
